### Notes on completion of the Application Form

It is essential that you complete all parts of the Application Form in accordance with the following instructions:

#### 1. Section A - Application details

Using black ink and capital letters, please insert the full name and address of the applicant in Section A as you wish it to appear on the Ocean Capital Bonds register, should your application be successful. Applications can ONLY be made in sole names by persons who are over the age of 18 or by companies, trusts or charities.

#### 2. Section B – Contact Details

#### 3. Section C - Application amount

#### 4. Payment by Cheque

Payments made by cheque or bankers' draft must be in pounds sterling, drawn at a branch of a bank or building society in the UK, Channel Islands or the Isle of Man.
